# Overview

**LandTrack Systems** offers a suite of tools built for mining industry professionals to help acquire, protect, manage, report, and track mineral title compliance, tenure-related agreements, and environmental conditions. **LandTracker** is a multi-jurisdictional asset and compliance management system that leverages key government databases, securing company's tenure with exclusive technology and audited data. This customisable system integrates seamlessly with your organisation's compliance processes, safeguarding your holdings and streamlining management. **Expenditure Watch** fills the gaps between the accounting system, tenement administration and exploration planning. Expenditure Watch is designed specifically to address difficulties with traditional tenement expenditure reporting. **GeoSearch** is a land monitoring tool built to acquire new ground and protect your tenure with automated alerts about land use changes in your specified area of interest. **Tenement Safety Net** sends concise, timely reports detailing critical compliance actions across your land assets.

# LandTracker Udon Patch Release Notes (24 July 2025)

---

## Enhancements

- LandTracker now supports Single Sign-On (SSO) for external Active Directory (AD) logins to authenticate connections to Databases in LandTracker Azure. This allows users from external organisations to log in securely using their own AD credentials.
- Added the ability to import Brazil (BR), Peru (PE), and Canada-Quebec (CA-QB) Jurisdictions from LandTracker Data Service.

## Defect Fixes

- **Freshdesk case: 215442** New tenement applications sometimes did not appear or showed no data during import, risking missed compliance deadlines. A new alert now notifies users of applications from the last 30 days not yet in Land Tracker to support timely compliance.
- **Freshdesk case: 182739** The system previously relied on hardcoded action names to recognise and trigger workflows. It now supports application-level mappings, allowing users to define alternative action names that the system can interpret correctly.
- Overdue Final Form 5s continued to appear in reports even after tenements had been dead for over six months. These are now excluded once a tenement has been dead for more than 59 days, keeping compliance reporting clear and relevant.





# LandTracker Udon Patch Release Notes (8 May 2025)

## Enhancements

- Added **ACN** column to **Related Data** in the WA tenement **Holders** tab.
- Added **Datum** and **Boundary** columns to data grids for WA tenements.
- **Freshdesk cases: 194066 and 222578** Added feature to disable action definitions by using the **Is Active** column in **Manage Actions**. This stops new actions from being calculated and does not affect historical actions.
- **Freshdesk case: 205338** Updated **Alert Filter** in **Manage Alert** screen to be sorted alphabetically.

## Defect Fixes

- **Freshdesk case: 221737** Fixed defect of **Dead Tenements** creating combined reporting groups when updating from LandTrack Data Service.
- **Freshdesk case: 221230** Fixed defect with the user update from LandTrack Data Service for the CA-BC region.
- **Freshdesk case: 211074** Fixed defect with populating **Group** columns when using the **Action Task** view.
- **Freshdesk case: 212357** Fixed defect with parent template causing application error in the **Action Task** view.

## Enhancements

- **Freshdesk case: 218430** Allow multi-line editing and pasting with keyboard shortcut **Ctrl+Enter**.
- Improved security and trust by signing all LandTracker executables and libraries.

## Defect Fixes

- **Freshdesk case: 210478** Resolved an issue with non-shared custom view that appears to other users.
- Resolved an issue with **Dynamic: All Assets** being removed or renamed causing the **Global Filter** to be empty when starting LandTracker.
- **Freshdesk case: 208586** Resolved an issue with disappearing underscores in context menus.
- **Freshdesk case: 218874** Resolved an issue with duplicated compliance renewal records.

## Enhancements

- The dashboard has been updated to provide direct access to the new LandTracker product documentation. The updated User Guide can be accessed from the **Help** section by clicking **User Guide**.
- Templates are available on the documentation website. Access these in the **Configuration** section of the dashboard by clicking **Open Templates Page**.
- The outdated **Wiki** button has been removed from the **Actions** tab for a cleaner user experience.

## Defect Fixes

- **Freshdesk case: 213975** Resolved an issue with the Quick Appraisal login where users encountered an *Access Denied - Error 15* message.

## Defect Fixes

- Fixed issue related to deleting rows from related data types.
- Fixed issue of invalid dates when calculating Consumer Price Index (CPI).

## Wardens Court Data

Western Australia's Wardens Court data is available to import into LandTracker.

The **Agreements** module offers clients template functionality that imports the Wardens Court data, allowing you to create automated actions based on next mention hearing dates. This functionality offers incredible benefit to users managing hearings. Creating automated actions ensures you will not miss a hearing date. Contact the LandTrack Systems team to implement this template within your system.

The **Tenements** module has template functionality that creates a **Wardens Court** tab within the details pane of the **Tenements** asset browser. Wardens Court listings display within a child table. Create ad hoc actions based on this data.

**LandTracker Due Diligence** receives the data, allowing simple and streamlined auditing.

## Asset Data Management

The **Copy to Parent** feature is template functionality that allows users to copy data from one asset to another in a different module. For example, you can copy holder information from a tenement directly to a related agreement.

## Alerts

Alerts have an option to include a report as a spreadsheet, streamlining administration for users.

An **Exclude Excel** column has been added to **Alert** report columns to be used when excluding specific reports from the Excel attachment.

## Action Filters

The **Incomplete due next 12 months** filter displays actions that have not been flagged as complete and are due from now until the end of the 12th future month. For example, if today is the 5th of August 2024, actions up to the 31st August 2025

display.

## Enhancements

- Custom fields can use a **LinkedRow** tag to get the value from its **LinkedRowID** child asset.
- Due Diligence displays a more informative message in dialog box when failing to open SQL connection.
- Additional validation and warnings display when detecting invalid parents (orphaned records). LandTracker confirms before saving, with an option to continue editing.
- The **#asatdate#** token is supported in the subject of an alert.
- In a template, an actual date can be used with **EarliestActionDate** instead of a reference to a field.
- The **Tenement Details Excel Merge** templates include Warden's Court data for LandTracker and Due Diligence.

## Defect Fixes

- Adding an URL without selecting any parent object (Ten ID) would cause an error. Buttons are now disabled when no valid parent is selected.
- An Ad Hoc Action could be created on the wrong tenement. Buttons are now disabled when no valid parent is selected.
- An issue has been fixed with the **Show on Dashboard** option in the **Actions** module.
